Application Requirements for Non-Iraqi Students (Arabs & Foreigners) at Al-Mustaqbal University College

- 1. The student has to submit a high School Certificate, recognized in Iraq and approved by the Ministries of Education and Foreign Affairs of the Student's Country, in addition to being endorsed, if available, by the Cultural Attaché at the Iraqi Embassy. Admission Entries for each Major shall be followed.
- 2. The Student is required to equalize his Certificate at the Ministry of Education in Iraq. Besides, he is obligated to accept all the Conditions and Laws included in the Student Affairs Procedure Manual as well as the Admission Rules of Private Colleges.
- 3. In case the Student has been accepted in the College, but he does not proceed after a specific period of time from the start of the study, his admission shall be deemed invalid.
- 4. The Student is obligated to submit a Medical Certificate issued by the School Health Directorate of his Country and Certified by the Iraqi Ministry of Health. This Certificate confirms that the applicant is free of Communicable Diseases. He should submit as well, a Vaccination Certificate against Smallpox, Typhoid and COVID 19.
- 5. The Student has to submit the Admission Application Form that shall be published later on the College Website, after being filled with the required information.
- 6. The applicant should be a Full-Time Student, and it is not permissible to combine Studies with Work.
- 7. Students are accepted according to Ministerial Orders issued by the Ministry of Higher Education, and on which University Orders including the Names of Accepted Students shall be issued and presented to the College Council for approval.
- 8. Distinguished Students, after the end of First Term, shall be included within the Free Scholarship, according to which they are granted Monthly Financial Assistance for Housing, Living and Traveling.
- 9. The Student shall be transferred from Half to Full Scholarship after the end of First Academic Year, provided that he achieves a Grade of Distinction.
- 10. The Student shall adhere to the Foreign Students Instructions issued by the Ministry of Higher Education in Iraq, in addition to being committed to the Laws & Instructions issued by the College.
- 11. The Student accepted on the basis of Half Scholarship is required to pay the Financial Dues specified by the College in the form of 4 batches during the Academic Year.
- 12. The Student accepted on the basis of Full Scholarship shall be exempted 100% of the Tuition Fees.

The student is assumed to meet the Minimum Admission Requirements, and according to the options displayed in the Application Form. The Minimum Acceptance Threshold is as follows:

- 1. Medical Specializations: Pharmacy & Dentistry. Students with a High School, Scientific and Biological Branches, or equivalent, with an Average Degree of not less than 80%.
- 2. Engineering Specializations: Bio-Medical Engineering, Chemical Engineering & Petroleum Industries. High School Students, with an Average Degree of not less than 72%.
- 3. Health & health Techniques Specializations. High School Students, with an Average Degree of 70%.
- 4. Engineering Techniques Specializations. High School Students, with an Average Degree of not less than
- 5. Law Major. High School Students, with Minimum Average Degree of 65%.

6. Students are accepted in the Majors of Business Administration, Accounting, Physical Education, Media, and English language according to the Comparison System, with a Minimum Average Degree of 50%.

The College shall adopt the Mechanism of a Comparison System in accepting applicants, and according to the conditions announced at the Official Website of the University.
