COURSE TITLE: " **IRAQI ENERGY LAW AND SUSTAINABILITY** "

This course analyses and examines the legal aspects of the creation of the Single Energy Market in the Middle East and Iraq. In particular, it examines energy sources and energy products in the Republic of Iraq; hydrocarbons and the conditions for their exploitation; upstream and downstream markets; the transport of energy resources; renewable energy sources; environmental risks and how to deal with them; climate change and the climate crisis; as well as the policies for the transition to a decarbonized economy. Emphasis is also placed on the geopolitical implications of Iraq's dependence on energy sources of foreign origin and on the efforts made to decarbonize Iraq.

COURSE TITLE: " **DATA PROTECTION AND INFORMATION, COMMUNICATION, AND TECHNOLOGY LAW OF IRAQ** "

This course reviews basic concepts concerning data protection based on a theoretical analysis of privacy in the 21st century And the Iraqi regulations, particularly given the exceptional circumstances that arose within the context of the recent COVID-19 pandemic, Furthermore,

COURSE TITLE: "*ECONOMIC CRIMES IN IRAQI LAWS AND REGULATIONS*"

Al-Mustaqbal University College hosted This course was attended by numerous faculty members, students, and our external stakeholders to familiarize them with the basic concepts of international (and particularly Iraq-based) economic criminal law and to address some of the core problems concerning the use of substantive criminal law in the fight against modern economic crime(s).

During the course, we examined the historical evolution and the sources of international and Iraqi criminal law, the liberal guarantees enshrined in it, and the effects this legal field has on national criminal law and the general formation of anti-criminal policy. Its application in areas such as fraud against Iraqi financial interests, money laundering, corruption, and cybercrime was also analyzed.

Al-Mustaqbal University College attempts to clarify and better understand what economic crime is and the machinery of counter-economic crime, and to achieve the following educational and educational outputs:

- 1.raise awareness about the seriousness of economic crimes.
- 2.Train participants to recognize acts that fall under the purview of economic crime(s).
- 3.Provide an opportunity to study all the successful experiences in addressing this crime in order to reduce its level.

Particular emphasis is placed on the directives of major practical importance, such as the directive on collective redundancies, the directive on the protection of workers in the event of the transfer of a business, the non-discrimination directive, and the directives concerning flexible forms of employment (fixed-term, part-time, and temporary employment contracts).
